- 6.1 The latest information on record was placed and considered.
- 6.2 It was noted that-
 - a) as per passed precedence PCI granted approval U/S 12 to the institution after approval of first batch passed out in D.Pharm, B.Pharm, Pharm.D, Pharm.D(PB) and B.Pharm Practice programme.
 - b) After judgement dt.29.05.2026 passed by Hon'ble Court of Delhi in respect of LPA No.614 of 2024 titled as PCI vs SLS College of Pharmacy, PCI has decided to change decision format.

- c) After revision of decision format, institutions and Students are facing difficulties in registration in State Pharmacy Councils and requesting to PCI to issue decision letter indicating approval U/S12, which are not yet granted approval U/S 12 by PCI and those institution covered under conduct of course category.

6.3 In view of above, it was decided to-

- i) The passed out students of 2025-2026 academic session from an institution approved by PCI for conduct of course are eligible for registration as Pharmacist under the Pharmacy Act 1948, if candidate fulfils all the conditions.
- ii) The admitted batch of 2025-2026 academic session and prior of an institution approved by PCI for conduct of course are eligible for registration as Pharmacist under the Pharmacy Act 1948, whenever they will passed out and if candidate fulfils all the conditions.
- iii) The approval letter issued by PCI for admission in passed for pertain to academic year, is considered for registration of student and treated as approval u/s 12.

6.4 It was further decided to inform to all State Pharmacy Councils in the matter.
