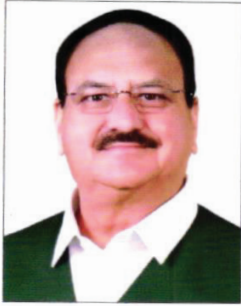

PCI Implemented Aadhaar Authentication to Increase Transparency

Streamlined Processes: It will simplify administrative processes such as registration, enrolment, and attendance tracking through secure and efficient Aadhaar-based verification.

Complete Transparency: Aadhaar authentication will promote greater transparency within the pharmacy sector by fostering a system based on verified and reliable data.

The official launch date for the Aadhaar authentication process is undisclosed. However, the PCI is actively developing the necessary

software infrastructure to support its implementation. This initiative is expected to benefit various stakeholders within the pharmacy ecosystem, including students, teachers, pharmacists and pharmacy institutions. It will ensure secure and efficient identity verification while enhancing data accuracy and administrative efficiency.

2. Specialization in the last two years: Students will have the opportunity to pursue specialization in an area of interest, such as pharmacology, pharmaceutical chemistry, or pharmacy practice, during the last two years of the course.

3. NEP 2020 Alignment: The revised curriculum is designed to align with the NEP 2020, which emphasizes the importance of flexibility, autonomy, and specialization in higher education.

4. Bridging the Skill Gap-Integration of skill development courses: The Pharmacy Council of India's (PCI) decision to integrate skill

development courses designed by the Life Sciences Sector Skill Development Council (LSSSDC) into the B. Pharm program is a strategic move that will have a profound impact on the employability and career prospects of pharmacy graduates.

3. Flexibility: The revised curriculum offers

flexibility to students, allowing them to choose their area of specialization and pursue their interests.

4. Industry Relevance: By aligning with NEP 2020 and the pharmaceutical industry's requirements, the curriculum ensures its relevance and prepares students to tackle the complexities and challenges of the profession, fostering a seamless transition from academia to industry.

By aligning the B. Pharm curriculum with NEP 2020, the PCI has made a landmark stride in addressing the skill gap in pharmacy education. Raising the Bar: PCI Joins Hands with QCI

The Pharmacy Council of India (PCI) is revolutionizing the assessment and rating system for pharmacy education institutes in India by shifting from a compliance-driven model to one that fosters a culture of excellence. To achieve this, PCI has partnered with the Quality Council of India (QCI)- an autonomous body set up by Ministry of Commerce and Industry, to develop a cutting-edge assessment and rating system that focuses on regulatory compliance and outcomes. The collaboration has formulated 11 criteria and associated parameters for evaluating pharmacy educational institutes, with the ultimate goal of enhancing the overall quality of pharmacy education in India.

The initiative is being led by the Ministry of Commerce and Industry, which has experience

in creating frameworks for assessing and rating medical institutions in India. The PCI will evaluate the assessment and rating ecosystem in a phased manner, starting with pilot-testing of draft criteria and parameters with select pharmacy institutes from different regions. The insights gained from these pilot assessments will inform the strategy for broader implementation of the new evaluation and rating system.

This strategic collaboration between PCI and QCI demonstrates a commitment to creating a culture of continuous improvement and excellence in pharmacy education. The goal is to establish a transformative system that ensures compliance and elevates the educational experience, setting new benchmarks for quality in pharmacy education



PCI Ponders Upon Equivalence Degree for Global Students

The PCI looks forward to forging a global pathway for Indian pharmacists studying abroad. The institute has taken a proactive stance by engaging in discussions with international universities for conducting equivalence degree. This will ensure that Indian pharmacists studying in international universities can practice in their homeland.

In the past, PCI was inundated with inquiries from Indian pharmacists studying abroad. They often sought clarification on the equivalence course undertaken at international institutions. To provide a platform to these professionals and to allow them to integrate into the Indian healthcare system, the PCI is considering equivalence degree.

The PCI is in discussion with international universities to implement the same. This will allow Indian pharmacists to showcase their skills and knowledge through an examination. The PCI draws inspiration from successful models like the National Medical Commission (NMC) to ensure successful implementation. The PCI may also collaborate with the National Boards of Examinations in Medical Sciences (NBEMS) to conduct the exam.

The PCI is committed to carving a clear pathway for the global community of Indian pharmacists so that they can start practicing in their homeland whenever required. This equivalence exam will also bridge international education and professional practice, opening streamlines for Indian pharmacists from foreign lands to contribute to India's healthcare landscape.



The Council Launches Extra Mural Schemes for Faculty and Pharmacists

The Pharmacy Council of India has undertaken various initiatives and channelled funds into various mural schemes to foster to development of pharmacists, students and faculty. These schemes include:

A. Pradhan Mantri Scholarship for Pharmacy Post Graduate Studies (GPAT)-(PMSPPS):

It supports the pursuit of higher education. Students pursuing postgraduate studies can avail of scholarships under this scheme. It will boost academic excellence among pharmacists and students.

The budget amounting to Rs.300.00 crore is allocated (Rs 12,400/Month)(3 Lacs/candidate for 2 years)

B. Research Development Scheme (RDS):

This scheme is introduced to foster a culture of research. Under this scheme, the researchers will be provided funds and resources to undertake research projects that contribute to developing innovative pharmaceutical solutions.

The budget amounting to Rs. 30.00 crore is allocated (upto 15 Lakh)

C. Doctoral Fellowship (DF):

The Council is keen to promote advanced academic pursuits. Under the Doctoral Fellowship scheme, the Council will encourage pharmacists and scholars to undertake

doctoral research. This initiative will further contribute to knowledge expansion in the field of pharmacy.

The budget amounting to Rs. 10.00 crore is allocated (200 Students (35,000/Student)

D. Capacity Building Industrial Training (CBIT):

This scheme exclusively focuses on the practical aspects of the profession. It aims to enhance the skills and competencies of pharmacists through industrial training. This way, CBIT aligns education with industry demands.

The budget amounting to Rs. 1.00 crore is allocated (200 Teachers(50,000/Teacher)

E. Continuing Education Programme(CEP):

The Continuing Education Programme is designed to promote life-long learning as the pharmacy landscape is ever-evolving. CEP ensures that pharmacists stay updated with the latest advancements in the field. The institute has also provided the financial support of Rs. 5 lakh under this scheme.

The budget amounting to Rs. 3.00 crore is allocated (100 Institutions (3 Lacs/Institution)

F. Refresher Course for Pharmacists:

Pharmacy is a dynamic field, re-shaped with frequent changes. The PCI has initiated a Refresher Course for Pharmacists, acknowledging the need for periodic skill reinforcement. It will allow them to refresh their

knowledge and match steps with the rapidly evolving pharmacy landscape.

The budget amounting to Rs. 1.00 crore is allocated (4 refresher courses/year (50,000*4)2 Lacs/year/Council)

G. Skill Development Centre for Pharmacists (SDCP):

The Council has launched the Skill Development Centre for Pharmacists to address skill gaps and ensure a highly skilled workforce. The course focuses on honing the practical skills required in the pharmaceutical industry.

The budget amounting to Rs. 75.00 crore is allocated (2.5CR/Centre(one Centre in each state)

H. Professional Development Fund (PDF):

The Council wants to encourage professionals to invest in their professional growth without worrying about finances. The Council's Professional Development Fund provides financial support to pharmacists and educators so that they can undertake career-enhancing activities.

The budget amounting to Rs. 1.00 crore is allocated (20-30 members/year (upto 3 Lacs/year)

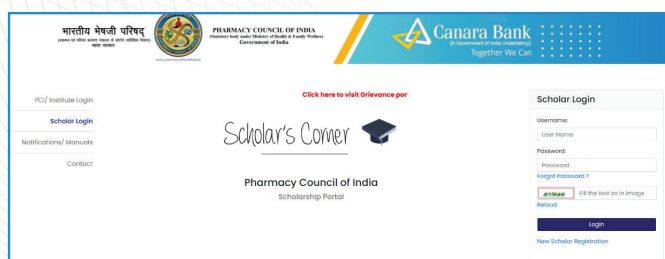
Provision has been made in the budget to strengthen the State Pharmacy Council and allocated fund of Rs.1 crore (minimum 2 SPCs / year).

The GPAT scholarship is a game-changer for pharmacy students, providing them with the resources and education they need to succeed in the pharmaceutical industry. With the PCI allocating around 300 crores for the scholarship, it's clear that they're dedicated to supporting the next generation of pharmacists. This move will undoubtedly fuel the dreams of hundreds of pharmacy students, giving them the opportunity to flourish in this dynamic field.

In the task-shifting and sharing model, Clinical Pharmacists are also given additional responsibilities to contribute effectively to the comprehensive healthcare delivery system. The Health Ministry is currently reviewing the proposed changes. However, the Council has asserted that more recognition and opportunities are needed for PharmD students.

PCI and UGC Join Forces to Establish Anti-Ragging Cells in Colleges

PCI Collabs with Primary Agriculture Credit Society (PACS) under Ministry of Cooperation, Government of India for opening of Jan Aushadhi Kendras

The Pharmacy Council of India (PCI) has collaborated with the Ministry of Chemicals and Fertilizers, the Department of Pharmaceuticals, and the Pradhan Mantri Bhartiya Jan Aushadhi Pariyojana (PMBJP) to expand access to affordable medications. This will be done by opening Jan Aushadhi Kendras (JAK) under the Primary Agriculture Credit Society (PACS) category.

The PCI President received a proposal and presentation regarding the opening of JAKs under PACS in October 2023. Subsequently, all state and UT Pharmacy Councils were informed and invited to participate in an online meeting to discuss the initiative. Following the initial meeting, the PCI received a communication from PMBJP regarding the free registration of pharmacists on their website. This information was promptly disseminated to all relevant stakeholders through the PCI website. Additionally, a list of state-wise coordinators and members was forwarded to PMBI for further collaboration.

In January 2024, a high-level meeting was convened with representatives from PMBI (Pharmaceutical and Medical Devices Bureau of India), PCI, and the Ministry of Home Affairs and Ministry of Health and Family Welfare. The meeting was attended by Shri Amit Shah, Hon'ble Home Minister of India and Shri Mansukh L Mandaviya, Hon'ble Health Minister of India. This

meeting solidified the commitment to this collaborative effort.

Further discussions and a virtual meeting with PMBI ensured that pharmacists could register online, which made it easier for them to participate in the JAKs under PACS. This initiative will improve access to affordable and essential medicines for rural communities across India.



This collaborative approach between the PCI, PMBI, and other government bodies reflects a shared commitment to improving healthcare accessibility and ensuring the well-being of citizens throughout the country, even in the remotest rural areas and PCI provided more than 5000 pharmacists.

Govt. has ambitious plans to open 25000 JAK's in India and hence there will be a regular demand of registered pharmacist both in Urban as well as rural areas.

This step shall increase the numbers of registered pharmacist nationwide, specifically in rural areas and it may also increase the participation of young entrepreneurs for implementation of this flagship scheme PMBJP, where young pharmacists may have the option of choosing their carrier with PMBJP by opening of Jan Aushadhi Kendras with the these of **"Sewa Bhi Rojgar Bhi"**.

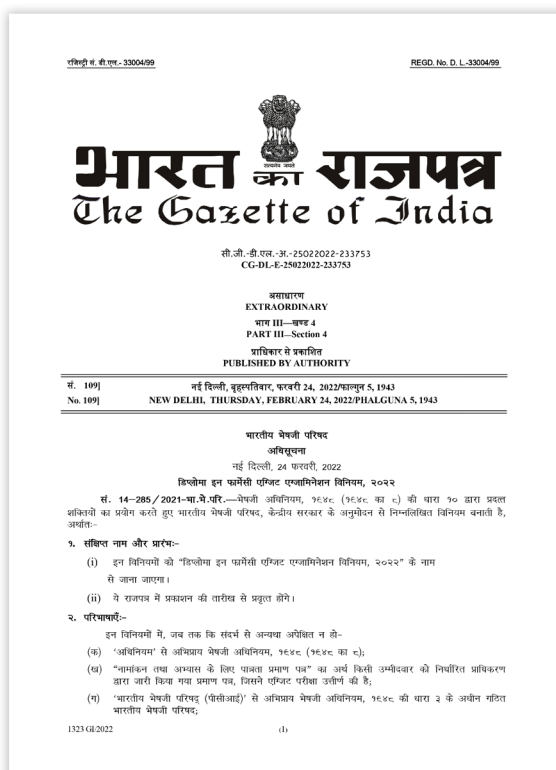


Scope of Pharmacists in Veterinary Services

PCI Initiated Online Course on Rational Use of Drugs with WHO and THSTI

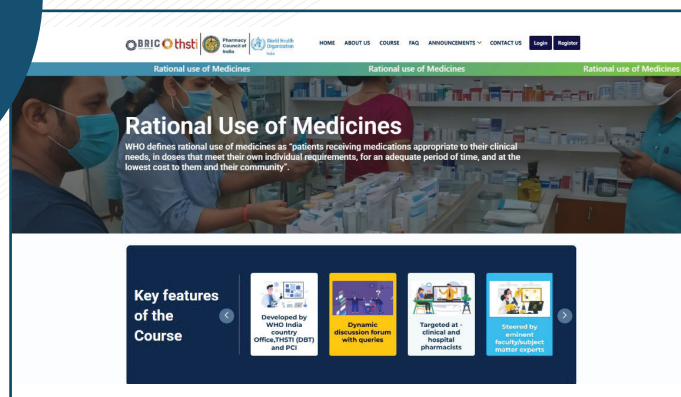

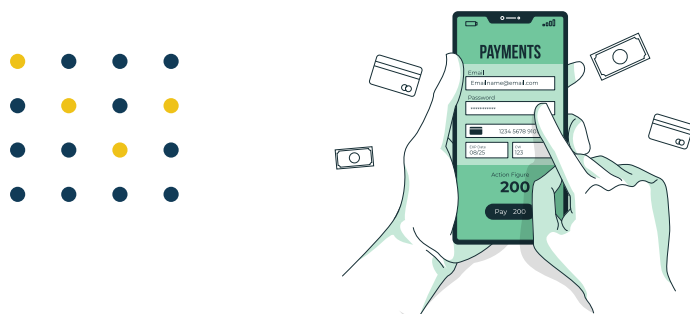

The following Act of Parliament received the assent of the President on the 11th August, 2023 and is hereby published for general information:—

THE JAN VISHWAS (AMENDMENT OF PROVISIONS) ACT, 2023
No. 18 of 2023

[11th August, 2023.]

An Act to amend certain enactments for decriminalising and rationalising offences to further enhance trust-based governance for ease of living and doing business.

BE it enacted by Parliament in the Seventy-fourth Year of the Republic of India as follows:—

1. (1) This Act may be called the Jan Vishwas (Amendment of Provisions) Act, 2023.

Short title and commencement.

(2) It shall come into force on such date as the Central Government may, by notification in the Official Gazette, appoint; and different dates may be appointed for amendments relating to different enactments mentioned in the Schedule.

2. The enactments mentioned in column (4) of the Schedule are hereby amended to the extent and in the manner mentioned in column (5) thereof.

Amendment of certain enactments.

3. The fines and penalties provided under various provisions in the enactments mentioned in the Schedule shall be increased by ten per cent. of the minimum amount of fine or penalty, as the case may be, prescribed therefor, after the expiry of every three years from the date of commencement of this Act.

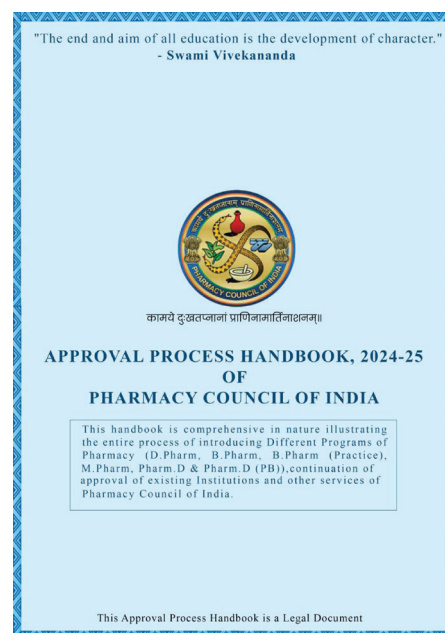


PCI Publishes Consolidated Approval Process Handbook For Introducing New Pharmacy Programs

This is a welcome development for the pharmacy education sector in India, as it is expected to improve efficiency and facilitate the growth of qualified pharmacy professionals in the country.

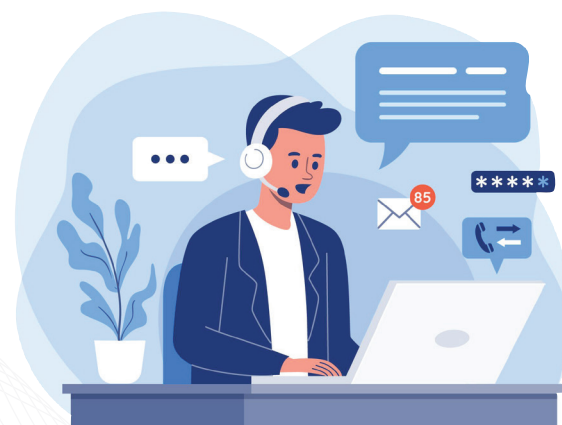
