With reference to the subject cited above, I am directed to inform the clarification regarding Appeal/compliance to be submitted by the institutions as per order dt.8.9.2025 passed by Hon'ble Supreme Court regarding academic calendar as under –

<p>Appeal/Compliance to be submitted by the Institution for Academic Session 2026-27</p>	<ul style="list-style-type: none"> <li>• <b><u>For Compliance of Statutory Documents for new institutions</u></b> For compliance of the Statutory documents, seven days time be given for submission of complete documents to the new institutions applied first time.</li> <li>• <b><u>Compliance on deficiencies pointed out by Executive Committee on inspection report.</u></b> Seven days' time be given to the institutions to submit compliance on deficiencies pointed out by Executive Committee on inspection report from the date of communication of EC decision.</li> </ul>

	<ul style="list-style-type: none"><li>• <b><u>For Appeal</u></b> Fifteen days (15) time be given to the institutions to file an appeal from date of communication of EC decisions –<ol style="list-style-type: none"><li>i) if institution failed to submit Compliance on deficiencies pointed out by Executive Committee on inspection report within 7 days.</li><li>ii) if institutions' application is rejected / Not to make admissions / not approved by EC after considering the compliance.</li></ol></li></ul> <p>Please note that –</p> <ol style="list-style-type: none"><li>a) compliance / appeal submitted on PCI Portal only will be accepted and no hard copy/ e.mail etc. will be accepted.</li><li>b) no further opportunities will be given to the institution after 15 days to file the appeal and application will be automatically rejected.</li></ol>
