All pharmacists intending to apply for the Pharmacist Awards are advised to:

1. Access the Pharmacist Awards Portal through the designated portal link <https://digipharmed.pci.gov.in/>
2. Login using their valid BH-P Number and complete the required process via filling up necessary details.
3. Carefully fill in all the requisite details and upload the supporting documents, wherever applicable.
4. Review the information entered before submitting the application.
5. Ensure that the application is submitted successfully within the prescribed timeline, as applicable.

A detailed User Manual for the Pharmacist Awards Portal is being attached for the kind perusal and guidance of all pharmacists. Applicants are advised to carefully go through the User Manual before initiating the application process to ensure smooth and successful submission of their applications.
